### Longtime shareholders have reinforced their positions

**DRONE VOLT, an expert in onboard artificial intelligence and manufacturer of professional civilian drones, has announced that it has raised €528.7k through a capital increase involving its longtime shareholders.**

The operation involved the issue and private placement of 2,658,301 new shares subscribed to by:

- DBI, a legal entity linked to Dimitri BATSIS, the founder of DRONE VOLT, for 1,023,259 shares
- HOBBY IMPORT, a legal entity linked to Jérôme MARSAC, a longtime shareholder of DRONE VOLT, for 1,635,042 shares.

This capital increase, conducted in the framework of the authorization given by the 10th resolution of the general shareholders meeting on April 27, 2018, took the form of a transformation of debts and related current liabilities into equity. This operation has reinforced the Group's equity funds and will enable it to conserve its financial resources in order to finance its development.

The exercise price was set at €0.19889 per share, corresponding to the weighted average share price over the five trading days preceding the operation without any discount, and enabled the Group to raise €528,709.

Along the lines of the ORNANE convertible bond issue announced at the beginning of the week, the objective of this capital increase was to pursue the diversification of the Group's financing and consequently limit its use of the OCABSA convertible bond issue program.

*"This renewed investment by longtime shareholders in the Group at the current share price constitutes a strong signal,"* indicated Olivier Gualdoni, chairman / CEO of DRONE VOLT. *"This investment demonstrates their involvement and support for the Group's strategy."*

The new shares will be admitted for trading alongside the previously existing shares. The equity stake held by a shareholder holding 1% of the company's shares prior to the capital increase and not having subscribed to the capital increase<sup>1</sup> now equals 0.9470%.
